Having examined the project application **D1 Jánovce – Jablonov highway**  
which is to be located at cadaster **Machalovce, Spišský Štvrtok, Dravce, Hľašovce,  
Kurimany, Levoča, Spišský Hrhov, Dol'any, Klčov, Nemešany a Jablonov**

we declare that (tick the appropriate box):

**The project is not likely to have significant effects on a site of nature conservation importance on the following grounds:**

The Project is aimed to continue building the D1 highway in next section. Planned section of the highway is more than 18 km long, it is linked with the section of the highway Mengusovce – Jánovce, which is in under construction in this time. This section proceeds to the east, south from the existing I/18 road, through the Šibenik tunnel (600 m long) to the end of this section interconnected with the proposed section of the Jablonov – Studenec highway. Planned section of the highway is not situated within the Natura 2000 sites (SCI – sites of Community importance and SPA – special protected areas). Nearest SCI is the SKUEV0107 Stráne pri Spišskom Štvrtku (approximately 180 m north from the planned highway), the SKUEV0111 Stráň pri Dravciach (approximately 1.1 km north from the planned highway) and the SKUEV0110 Dubiny pri Levoči (approximately 3.5 km north from the planned highway). Detailed situation is specified on enclosed map.

All project activities have been approved according to the national legislation (territorial planning or building permit procedure) and to all of them the official opinion from the involved nature and landscape protection Authority was needed.

Therefore an appropriate assessment required by Article 6 (3) of Directive 92/43/EEC was not deemed necessary.

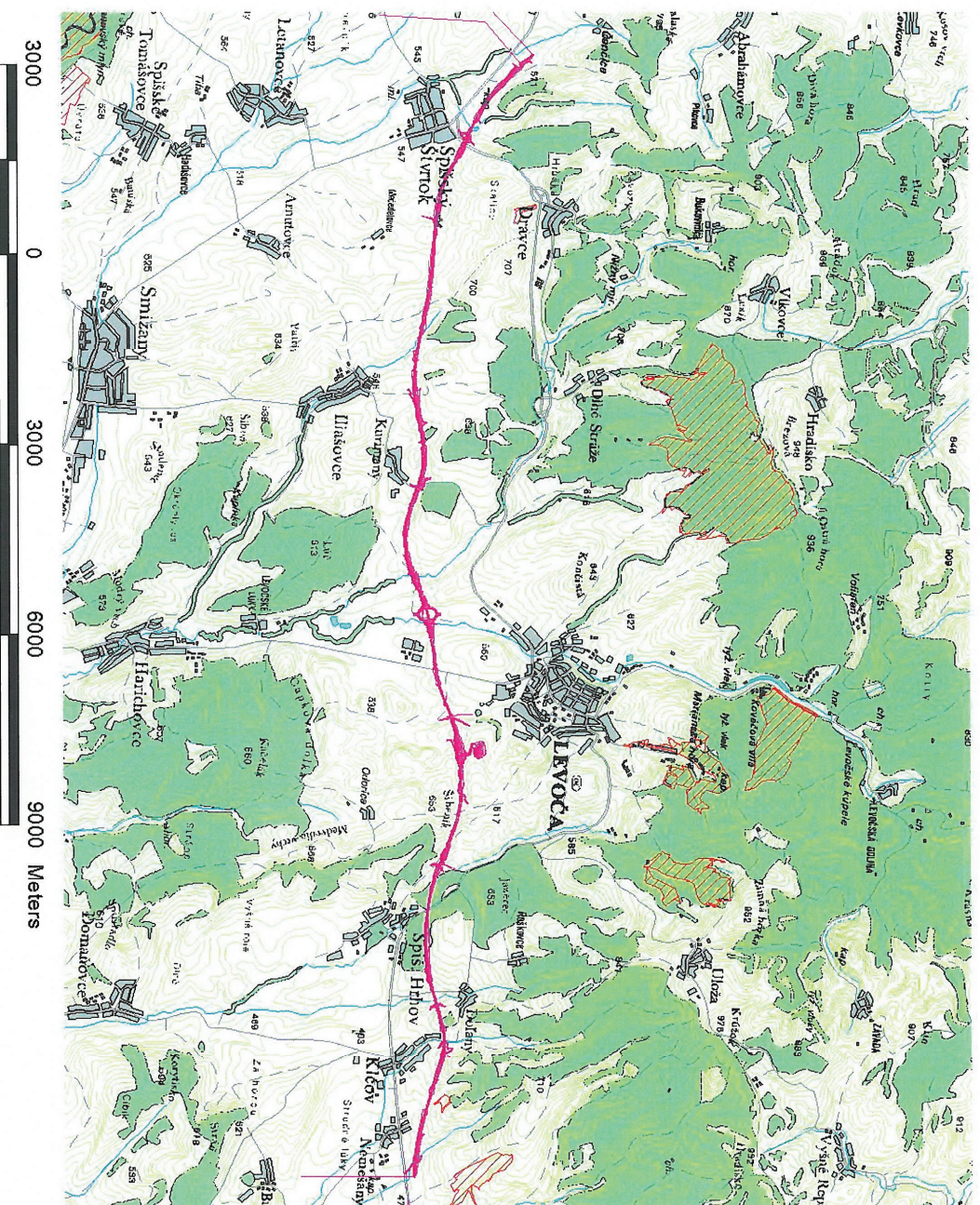

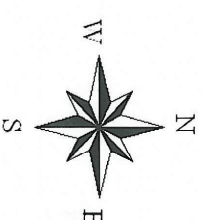
